#### **Event Schedule and Practice Ice**

#### **Medical**

There will be a medical station at ice level at the ice exit/zamboni doors. For any skater with existing medical conditions, please have team managers keep all medical forms inside the rink at all times.

#### **Parking**

- There are multiple athletic events on campus, plan for traffic and limited parking.
- Look for metered spots, small parking lots and parking garages on campus including:
- **Harry Agganis Parking Garage - \$1.00/Hour**
  - Outbound on Commonwealth Ave. to Buick Street. Turn right onto Buick Street and follow road to parking lot, which will be on left-hand side.

- Park near the West Exit on the second floor of the garage. Go up two flights of stairs, and you will see a door, which opens onto Harry Agganis Way. Cross the street and walk along the brick path, staying between Nickerson Field and the BU dorms.
- Take a left at the convenience store and go down a flight of steps. You are now on Babcock St. Turn right toward the Case Center. This walk is no more than 5 minutes.
- When you return to the parking garage, you again take the brick path to Harry Agganis Way. However, you can't go back through the same door, because it's locked. Walk up to Commonwealth Ave. and past the Agganis Arena. Between the arena and the fitness center is a courtyard. You will see a green parking sign that will lead you back to the parking garage, which is beneath the arena. This walk is approximately 7 minutes.
